How YOU CAN HELP PROTECT Berkshire Hathaway's Reputation

Berkshire Hathaway and its subsidiary companies have a firm commitment to ethical and legal business practices. We do not want to risk the reputation of any Berkshire company, or of any person who works for a Berkshire company. That is why each of you has a right and a responsibility to speak up if you witness behavior that you believe to be unethical or illegal, or if you are being pressured to participate in such behavior. Berkshire and its subsidiary companies prohibit retaliation against any person for making a good-faith report of illegal or unethical conduct.



SOME EXAMPLES OF REASONS TO SPEAK UP INCLUDE:

v Bribery

- Gifts, entertainment or other favors to gain improper influence
- Price fixing, bid rigging or sharing of sensitive information with competitors
- **O** Environmental protection breaches
- Trading with countries, companies or individuals in violation of U.S. sanctions
- Regulatory violations, for business operations like insurance, utilities, banking and transportation
- Insider trading
- Conflicts of interest created when personal dealings interfere with obligations to the company
- Misrepresentations to customers or suppliers
- Inaccurate books and records; falsifying or destroying company records or reports to regulators
- Fraud, theft or misuse of company assets
- Discrimination or harassment based on disability, race, ethnicity, religion or gender
- Bullying or abusive behavior
- Retaliation for reporting an integrity concern

YOU HAVE AN OBLIGATION TO REPORT SUCH MATTERS TO YOUR SUPERVISOR, YOUR LOCAL ETHICS LEADER, YOUR CORPORATE ETHICS OFFICE, YOUR LEGAL DEPARTMENT OR YOUR HUMAN RESOURCES REPRESENTATIVE RIGHT AWAY

Alternatively, if you want to report these types of activities to someone outside of your company, Berkshire has arranged for an independent organization, NAVEX Global, to receive reports of these types of activities. This service is available 24 hours a day, 7 days a week, and it provides an option for you to communicate concerns anonymously.

No employee will be retaliated against for making a good-faith report of illegal or unethical violations to the company.
